3. Approve Minutes of June 26, 2014 Meeting

4. Approve Minutes of June 30, 2014 Meeting

5. RFQ 946-11333 – Consultant Competitive Negotiations Act (CCNA) General Aviation Consultant Services – Contract Agreement

Mr. Pollitt informed the board he has a conflict of interest and would abstain from voting (conflict of interest form attached).

Staff recommended that the Board support the City approval of the hourly rates for HDR, Inc. and enter into a contract with HDR, Inc., to serve as the Airport's General Aviation Consultant for a period of up to two (2) years with two one (1) year renewal options. Task orders will be brought back to the Board and City Commission on a project-by-project basis as funding in determined.

Motion was made by Vice Chair O'Malley and seconded by Mr. Volchek to approve the staff recommendation. Motion passed (7-0 and 1 abstained).

6. Airfield Electrical Rehabilitation – Project No. 11997 - Joint Participation Agreement with Florida Department of Transportation

Staff recommended that the JPA be supported by the Board for the City to accept \$464,000 from FDOT for up to 80% of the project costs for providing design and construction services

Motion was made by Mr. Fauer and seconded by Vice Chair O'Malley to approve the staff recommendation. In a voice vote, motion passed unanimously.

7. Master Plan Update – Project No. 12070 - Joint Participation Agreement with Florida Department of Transportation

Staff recommended that the JPA be supported by the Board for the City to accept \$400,000 from the FDOT for up to 80% of the project costs for developing a Master Plan Update for FXE.

Motion was made by Mr. Volchek and seconded by Mr. Fauer to approve the staff recommendation. In a voice vote, motion passed unanimously.

8. Termination of Lease Agreement Parcel 8D Performance Trading Inc.

Staff recommended that the City Commission authorizes the City Manager to terminate the lease for Parcel 8D with Performance Trading, Inc. in accordance with Paragraph 16 of the lease. Staff shall work with the City Attorney's Office to pursue available legal remedies.

What is "Part 150"?

- 14 C.F.R Part 150, "Airport Noise Compatibility Planning"
 - Voluntary FAA-defined process for airport noise studies
- Two major components
 - Noise Exposure Map FAA "accepts"
 - Detailed description of airport layout, operations, noise exposure, land uses, and noise/land use compatibility for at least two years
 - Noise Compatibility Program FAA "approves" individual measures
 - Noise abatement measures to reduce noise exposure
 - Land use mitigation measures to address existing non-compatible uses
 - Land use control measures to prevent new non-compatible uses
- Consultation required with users and land use jurisdictions


Part 150 focusses on cumulative ("average") noise levels over an entire year.

Three Prior Part 150 Processes at FXE

- 1986 Submission
 - FAA found NEM in compliance in 1988
 - FAA published NCP "Record of Approval" in 1991
- 1994/6 submission
 - FAA found NEM in compliance in 1995, published ROA in 1997
- 2002 submission
 - FAA found NEM in compliance in 2004, published ROA in 2005
- Overall result has been a comprehensive noise program
 - Including noise abatement, compatible land use, and continuing program elements
- This submission is an NEM update for 2014 and 2019
 - To support City's commitment to monitor operations and noise, and provide up-to-date basis for continued land use planning

Most noise concerns at FXE relate to "single events"


- A-weighted decibel (dBA)
 - Reflects the manner humans hear different pitches of sound
 - Nearly universally used for environmental studies
- Single event metrics
 - Maximum sound level (Lmax)
 - "How loud did it get?"
 - Time-Above threshold (TA)
 - "How long will it affect me?"
 - Sound Exposure Level (SEL)
 - Noise "dose" over entire event



- FAA will not base Part 150 reviews on single event levels
 - Requires consideration of total annual noise exposure
 - Day-Night Average Sound Level

Day-Night Average Sound Level ("DNL" or "Ldn")


- Measure of cumulative noise
- Equal to steady level that contains same energy as the actual time-varying sound
- 10 dB "penalty" on sounds from 10 pm to 7 am
- Nearly every state and federal agency uses for land use compatibility purposes
- Part 150 provides compatibility "guidelines" – City has adopted
- All land uses are considered compatible outside 65 DNL




Noise Modeling

- Part 150 requires that noise exposure be determined using the FAA's Integrated Noise Model ("INM")
 - Results presented in the form of noise contours
- Noise modeling inputs include:
 - Average daily arrivals and departures
 - By aircraft type
 - By time of day
 - Arrival and departure "cockpit" procedures
 - Airfield layout
 - Percentage use of runways (by aircraft type and time of day)
 - Flight track geometry and use (by aircraft type and time of day)
 - Meteorological data
- FXE "ANOMS" provides excellent, objective data


Draft 2014 NEM

Major Conclusions

- Contours have shrunk approximately 5 dB since 2002
- No noncompatible land use within 65 dB DNL
 - Why?
 - Fewer operations overall
 - Retirement of older noisier Part 36 "stage 1 and 2" jets






Noise Monitor Locations




Jet Arrival Flight Tracks




Jet Departure Flight Tracks




Propeller Arrival Flight Tracks




Propeller Departure Flight Tracks

In 2010, the Board was informed that the Federal Aviation Administration (FAA) advised the City that the Land Use (Park/Open Space) and the existing Zoning for the Parcel 19B (Commerce Center) and Parcels 25, 26, & 27 (Parks, Recreation and Open Space) for the stadium and adjacent properties at Executive Airport are not acceptable. The surplus property deed restrictions require the use of the property for "public airport purposes and only public airport purposes." The parcels include the Fort Lauderdale Stadium, the practice fields, Lockhart Stadium, and adjacent vacant parcels.

As background, Broward County required the Land Use designation be changed prior to any City initiated rezoning. The City completed the underlying Land Use (LU) by changing from "Parks and Open Space" to "Transportation" LU designation, in compliance with the FAA mandate. In June 2010, the land use amendment was approved by Broward County Commission and a recertification hearing was conducted by the Broward County Planning Council and approved in March 2014.

As the Board is aware, the City is negotiating an agreement with Schlitterbahn to construct a water park, soccer fields, and retain Lockhart Stadium for the Fort Lauderdale Strikers soccer team on the above-stated parcels. In addition to meeting the FAA requirements for the Airport property and proposing a zoning change to GAA, the City also needs to amend the text for the GAA zoning district under Conditional Uses to allow for the existing stadium use as well as the proposed water park and accessory uses.

The City is proposing a text amendment to the Unified Land Development Regulations (ULDR) that will allow Limited Recreational Uses as a Conditional Use under the General Aviation Airport (GAA) zoning district. Limited Recreational Uses would include gymnasiums, athletic fields, stadiums, and amusement parks. This text amendment is necessary to allow the existing stadium uses as legal conforming uses under the GAA zoning district and to provide an approval process for the proposed Schlitterbahn waterpark uses as a Conditional Use.

Staff Recommendation

Staff recommends amending the text of the General Aviation Airport (GAA) zoning district to allow Limited Recreational Uses as a Conditional Use as stated in the proposed text amendment.

In 2010, the Board was informed that the Federal Aviation Administration (FAA) advised the City of Fort Lauderdale that the Land Use (Park/Open Space), at that time, and the existing Zoning for the Parcel 19B (Commerce Center) and Parcels 25, 26, & 27 (Parks, Recreation and Open Space) for the stadium and adjacent properties at Executive Airport are not acceptable due to the surplus property deed restrictions that require the use of the property for "public airport purposes and only public airport purposes." The parcels include the baseball stadium, practice fields, Lockhart Stadium, and adjacent vacant parcels. **Exhibit 1** depicts the current zoning map and the proposed zoning map amendments for the above-stated parcels.

As background, Broward County required the Land Use designation be changed prior to any City initiated rezoning. The City completed the underlying Land Use (LU) by changing from "Parks and Open Space" to "Transportation" LU designation, in compliance with the FAA mandate. In June 2010, the land use amendment was approved by Broward County Commission and a recertification hearing was conducted by the Broward County Planning Council and approved, in March 2014.

The City is initiating a zoning map amendment for the above-stated parcels to meet the FAA requirements for Airport property to change the existing zoning for Parcels 19B, 25, 26, and 27 to General Aviation Airport (GAA) zoning district.



	Downtown Helistop – Invitation to Bid (ITB 532-11229)

The Board may recall from the July 19th Aviation Advisory Board meeting that a recommendation was made to award the painting contract for the John Fuhrer Downtown Helistop to Fitch Builders Incorporated in the amount of \$70,860. The contract would provide for cleaning and painting of the space-frame structure, fireproofing material on the sub-structure supports underneath the space-frame, painting of the security enclosure and replacement of structural pipe hangers for under-deck drains. In addition, the contract calls for annual inspections and includes a five (5) year warranty on labor and materials.

Upon mobilizing to perform the work, Fitch Builders Incorporated informed staff that due to changing market conditions they would be unable to complete the work at the contracted price. Staff reached out to the only other bidder, Roof Painting by Hartzell, and they indicated that they could still honor their original price of \$95,268. Reference checks for Roof Painting by Hartzell were satisfactory. Due to the limited response to the original invitation to bid it is staff's opinion that rebidding the project would not be beneficial.

Staff Recommendation

Staff recommends cancelling the contract with Fitch Builders Incorporated and awarding the contract to Roof Painting by Hartzell in the amount of \$95,268.









The Notice to Proceed (NTP) for Project #12069 – Earthwork Improvements Parcels B-C-D was issued on July 1st. Work to date includes final installation of fill and perimeter berm on parcel B, de-mucking of parcel C, final installation of fill and sifting of fill pile on parcel D. The project is on schedule and expected to be completed in October 2014

<u>#P11242 U.S. Customs and Border Protection Facility</u>

The NTP for the construction of the new 7,900 square foot United States Customs and Border Protection Facility was issued on February 12th. Work completed since the last Board update includes installation of the upper and lower roofs, first lift of ramp asphalt, and delivery of the reclaimed water irrigation cistern. The project is on schedule and expected to be completed in April 2015.
