A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE CITY MANAGER TO ACCEPT GRANT FUNDS IN THE AMOUNT OF \$96.336 FROM THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY. FEDERAL MANAGEMENT AGENCY 2012 ASSISTANCE FIREFIGHTERS GRANT PROGRAM: FIRE PREVENTION AND SAFETY EXECUTE ALL NECESSARY GRANT: DOCUMENTS TO OBTAIN SUCH GRANT FUNDING AND AMENDING THE FINAL OPERATING BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2012 AND ENDING SEPTEMBER 30, 2013 BY APPROPRIATING FUNDS AS SET FORTH IN THE ATTACHED EXHIBIT.

WHEREAS, in January 2013, the Fire-Rescue Department applied for funds through the United States Department of Homeland Security, Federal Emergency Management Agency's Assistance to Firefighters Grant: Fire Prevention and Safety Grant Program, whose purpose is to provide funds to national, state, local or community organizations that are recognized for their experience and expertise with respect to fire prevention or firefighter safety program and activities; and

WHEREAS, in June 2013, the Fire-Rescue Department was notified that its funding application for a Smart Fire Safety and Emergency Training Trailer was approved; and

WHEREAS, the Smart Fire Safety and Emergency Training Trailer is designed to reach high-risk target groups and mitigate the incidence of death and injuries caused by fire and fire-related hazards; and

WHEREAS, the grant will be \$96,336 from the United States Department of Homeland Security/Federal Emergency Management Agency with a 20% local cash match; and

WHEREAS, pursuant to Resolution No. 12-175, adopted on September 18, 2012, the City Commission of the City of Fort Lauderdale adopted the Final Operating Budget of the City of Fort Lauderdale, Florida for the Fiscal Year beginning October 1, 2012 and ending September 30, 2013;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Manager is hereby authorized to accept grant funds from the United States Department of Homeland Security, Federal Emergency Management Agency in the amount of \$96,336, execute all necessary documents to obtain such grant funding and amend the Final Operating Budget of the City of Fort Lauderdale for the Fiscal Year beginning October 1, 2012 and ending September 30, 2013 by appropriating funds as set forth in the Exhibit attached hereto and incorporated herein.

SECTION 2. That this Resolution shall be in full force and effect upon final passage.
