The purpose is to give public recognition to citizens who have contributed in significant ways to the development of the community. Honorees are selected by the Citizens Committee of Recognition and ratified by the City Commission. In 1984, the Citizens Recognition Program was expanded to include a Citizen of the Year, and a Distinguished Citizen Honoree. The category of Honored Founder was added to the awards program in 1990 and the category of Exemplary City Employee in 1997. In 2003 it was amended to Exemplary Former City Employee as the Board recognized that the City already had a program to recognize accomplishments of current City employees. Since the program's inception, the City has honored 84 outstanding citizens. He asked the previous award winners to stand and be recognized.
