CITY COMMISSION CONFERENCE MEETING 1:30 P.M. DECEMBER 2, 2008

<u>I-A – Downtown Development Authority - Interviews</u>

Gregory Durden and Dennis O'Shea provided background about themselves, their education, time in the city and interest in serving on this board.

Mayor Naugle noted requirements set forth in the enabling legislation and that a selection would be made at the regular meeting.

<u>I-B – Petition Requesting Street Light Wattage Upgrade – Progresso Village Civic Association</u>

Alfred Battle, Director of Community Redevelopment Agency, noted Progresso Village has requested upgrading to their street light wattage. Historically, he noted that nine neighborhoods have received such upgrades, the most recent being in 2004. Currently the City pays approximately \$8,100 to Florida Power and Light Company to service this area. The upgrade could be to 100 or 150 watts. For 100 watts, the annual cost would be \$8,900 and a little over \$10,000 for 150 watts. As it would be considered a maintenance expense, it could not be charged to the CRA. The backup information provided to the Commission shows area vacant lots and where crime has taken place. Also, staff is interested in some guidance as to policy moving forward in time.

The City Manager explained staff's concern is where to draw the line in terms of requests and increased cost. Mayor Naugle suggested this be done on a trial basis with a report from the Police Department in a year. This would be the only neighborhood in the trial for the one year period until the results are known and could be analyzed by a future Commission.

In response to Mayor Naugle, Doug Sterner of Progresso Village Indicated 100 watts with 150 watts at the Pantry (building) and perhaps some other spots. In response to Vice Mayor Rodstrom, Mayor Naugle noted a comparison of the 100 and 150 watts could be made by looking at the pantry.

Action: There was consensus approval for a one-year pilot program in this neighborhood only with a report from the Police Department at the conclusion so that a determination could be made as to effectiveness.

I-C – Affordable Housing Advisory Committee Draft Report

Peter Henn, Chair, Affordable Housing Advisory Committee, commented about the composition of the committee and varying views. He believed the report is manageable and does not go too far based on today's budget constraints. The goal is to secure funds for Fort Lauderdale. This draft report will be considered for adoption by the committee in two weeks and two weeks thereafter the Commission will consider adopting it. The proposal empowers the City's Housing Authority instead of a new group. The committee rejected two of the eleven state criteria.

Mayor Naugle understood the committee will hold a public hearing on December 15 and make a recommendation to the Commission and after another hearing, the Commission will make a decision on each item.

Vice Mayor Rodstrom asked if the density bonus issues would come before the Commission each time. Mr. Brewton indicated the Commission could make that determination. In further response to Vice Mayor Rodstrom, Mr. Brewton indicated that parking buy-down decisions would be made by the Commission on a project by project basis. Mayor Naugle pointed out a transit oriented development or one focused to the elderly might not have as much need for parking.

Vice Mayor Rodstrom requested another copy of a chart previously provided on median income levels and affordable housing.

Vice Mayor Rodstrom felt it would be great for this committee to work on the foreclosure program as well. Mr. Henn indicated the report has to be completed by the committee this year, but they recommend that the committee continue to serve in order to address other issues such as foreclosures. Vice Mayor Rodstrom agreed.

IV – City Commission Reports

Marshall Bridge (4 Avenue - 7 Avenue); noise

Commissioner Hutchinson indicated that the Tarpon River neighborhood has asked if something could be done about the noise from Marshall Bridge. She understood there is new technology that quiets the surface. She asked if there is consensus to request that Engineering submit a formal request to Broward County and inform Broward County Commissioner Rodstrom.

In response to Mayor Naugle, Commissioner Hutchinson agreed it would be great for a letter to be sent from the Mayor.

Mayor Naugle remarked about material placed on the Sunrise Boulevard bridge.
