Motion made by Ms. Helfer, seconded by Mr. Kerney, to support the findings of Internal Affairs.

Mr. Walters asked if the inconsistencies between the statements from officers on the roof and officers on the ground had been questioned. Specifically, Mr. Walters said, "The two... that came from the parking lot say that the person was shot while he was on the ground and the other three said that he was shot while he was backing up getting away from the person he had intended to rob..."

Capt. Maglione explained that Internal Affairs considered whether the officers had violated any policies or procedures and whether the force was justified. He said the inconsistencies had not concerned Homicide. Capt. Maglione had been present that evening, and neither he nor Sgt. Swisher, who had performed the original investigation, had been concerned. Mr. Walters had been worried about this because there were many times that officers had been cleared due to inconsistent statements given by complaining witnesses. He said he would vote in favor of the motion because the person had confessed that he committed the crime and apologized.

Chair Stotsky said he had been concerned about two officers missing when firing at someone over whom they were standing. He said the perpetrator had been very lucky that no significant damage had been done.

Mr. Trodella said the only thing that was a little bit troubling was that the female waiting in the car had not been forthcoming about "what she was doing and was there a plan." Capt. Maglione said it had never been confirmed, but it was suspected that they had robbed someone else earlier, and the location where this had occurred was a place someone would not frequent "unless you're looking for trouble. There's nothing, no businesses are open there."

In a voice vote, Motion passed unanimously.
