 of the Department, or official action of a supervisor when
 such criticism or expression is not a matter of public
 concern.
 2) Department personnel shall not post, transmit, or
 otherwise disseminate any information to which they
 have access as a result of their employment, or could
 reasonably be considered to represent the views or
 positions of this Department without the permission of the
 Chief or his/her designee.
 3) Engaging in speech that may provide grounds for
 undermining or impeaching an officer's testimony in
 criminal proceedings.
 4) Disrespect to a superior officer by overt actions.

5) Conduct prejudicial disruptive to the good order of the Department.

6) Engaging in conduct unbecoming a police officer/police department employee.
