Motion made by Vice Chair Dickerman, seconded by Mr. Walters, to accept the findings.

Mr. Staab asked if there were any mitigating factors that may have been involved in the case, such as medical issues. Capt. MacDougall explained that HPPA regulations prohibit any such information from being disclosed in a public forum. He noted that some information had been redacted from the report on the advice of the City Attorney.

In a voice vote, the **motion** passed unanimously.

C. General Information

Chair Jordan stated that the Board members make up a good team due to their backgrounds in law enforcement or involvement with the City. He asserted that he hoped the Board would make themselves more relevant in the new year by acting as "the eyes and ears" of the City's residents.

Officer Justice added that the Board should be privy to all the information generated on all cases that come before them so they could make informed decisions.

Mr. Walters responded that the Board cannot take any additional action, as the City Attorney has repeatedly advised the City Commission to take authority away from the Board. He recalled that at an earlier time, they had been able to suggest training or make recommendations to Internal Affairs regarding disciplinary action. He concluded that under a different City Attorney, it may be possible to return to this level of authority, which would promote greater trust from City residents. Chair Jordan agreed that he would also like to see the Board returned to its original level of responsibility.

Mr. Fling pointed out that the case files also go to the State Attorney's Office for review. Capt. MacDougall clarified that Internal Affairs deals only with administrative issues; if criminal activity has occurred, the file instead goes to Chief Adderley, who makes a determination on whether or not it should be sent to the State Attorney's Office.

Mr. Fling agreed with Mr. Walters regarding the Board's previous level of authority. He also agreed that the City Attorney was unlikely to change his mind with respect to what the Board may or may not do. Vice Chair Dickerman noted that a section of the Ordinance governing the Board had been removed, and should be reinstated. Mr. Walters said whenever the Board had gone before the City Commission to discuss this Ordinance, the result was that they lost even more authority.

Ms. Streeter offered to look into the history of the Ordinance that governed the Board. Mr. Walters recommended that Ms. Streeter view the first version of the Ordinance, as it has been cut back over the years.

There being no further business to come before the Board at this time, the meeting was adjourned at 6:23 p.m.
