**A. Roll Call**

**Motion** made by Mr. Walters, seconded by Officer Justice, to accept the findings of Internal Affairs.

In a voice vote, the **motion** passed unanimously.

Officer Justice asked if more information was available regarding the case discussed by the Board in October 2012, for which the members had requested a response from the City Manager. Sgt. Cortes said the City Manager is currently reviewing this case. He advised that a response from the City Manager could be expected at the next Board meeting.

Mr. Walters requested more information on this issue. Sgt. Cortes recalled that the Board had not agreed with the findings of Internal Affairs in this particular case, and had forwarded their findings to the City Manager, along with a request for a response including the City Manager's understanding of the case.

Sgt. Cortes continued that a response from the City Manager had been provided regarding IA Cases 13-004 and 12-028. He provided copies of the responses to the Board members, noting that the City Manager had not disagreed with the recommendations of the Board or of Internal Affairs.

Officer Justice requested an update on the status of a new City Attorney. Sgt. Cortes replied that he had no information on this issue at present.

There being no further business to come before the Board at this time, the meeting was adjourned at 6:11 p.m.
