Subject: Acquisition of Rivermont Property, 1016 Waverly Road – LWCF Grant

Staff will submit a grant application to the Florida Department of Environmental Protection for Land Water Conservation (LWCF) funds to assist in the acquisition of the Rivermont Property. The Rivermont Property is located at 1016 Waverly Road just south of Major William Lauderdale Park. If acquired, the 2.97-acre property will be developed as an addition to the adjacent .75-acre park. The park will create additional open and passive park opportunities with direct access to the North Fork of the New River.

While ensuring minimal impact to the onsite archaeological resources, the City of Fort Lauderdale Parks and Recreation Department will install a nature trail, educational observation site, a small boat dock and canoe launch. The existing 1,878 sq. ft. structure will be rehabilitated to preserve its historical integrity to serve as an educational facility. The facility will allow use as a gallery, lecture hall, and educational museum for exhibitions focusing on the history and development of life along the New River.

Vacant land on waterways in Broward County is rare and preserving this site for future generations is critical. Preservation of the site ensures the public access to the New River and the retention of waterfront property in perpetuity. Staff is requesting support of the grant application being prepared to support the acquisition of this site.
