### PROPOSED GOAL, OBJECTIVE AND POLICIES TEXT

### ADAPTATION ACTION AREAS

#### COASTAL MANAGEMENT ELEMENT

##### **GOAL 3:**

Increase the City's resiliency to the impacts of climate change and rising sea levels by developing and implementing adaptation strategies and measures in order to protect human life, natural systems and resources and adapt public infrastructure, services, and public and private property.

##### **OBJECTIVE 3.1:**

Develop and implement adaptation strategies for areas vulnerable to coastal flooding, tidal events, storm surge, flash floods, stormwater runoff, salt water intrusion and other impacts related to climate change or exacerbated by sea level rise, with the intent to increase the community's comprehensive adaptability and resiliency capacities.

*Evaluation Measure: Collaborating with regional partners, City shall identify public investments, infrastructure and assets at risk from rising sea levels by 2018. Thereafter, this assessment will be performed every five (5) years.*

##### **Policy 3.1.1:**

Identify public investments and infrastructure at risk to sea level rise and other climate related impacts. Assess the vulnerability to public facilities and services, including but not limited to water and wastewater facilities, stormwater systems, roads, bridges, governmental buildings, hospitals, transit infrastructure and other assets.

##### **Policy 3.1.2:**

Adaptation strategies may include, but not be limited to:

- a. Public infrastructure planning, siting, construction, replacement, operation and maintenance
- b. Emergency management
- c. Stormwater management
- d. Land development regulations
- e. Building codes
- f. Comprehensive planning
- g. Other strategies

##### **Policy 3.1.3:**

Adaptation strategy options may include the designation of Adaptation Action Areas (AAAs). As per Section 163.3164(1), Florida Statutes, an AAA is an optional designation within the coastal management element of a local government's comprehensive plan which identifies one or more areas that experience coastal flooding due to extreme high tides and storm surge, and that are vulnerable to the related impacts of rising sea levels for the purpose of prioritizing funding for infrastructure and adaptation planning.

**Policy 3.1.4:**

AAAs' adaptation strategy options may include, but not be limited to:

- a. Protection
- b. Accommodation
- c. Managed retreat
- d. Avoidance
- e. Other options

**Policy 3.1.5.:**

Considerations for AAAs designation may include, but not be limited to:

- a. Areas which experience tidal flooding
- b. Areas which have an hydrological connection to coastal waters
- c. Locations which are within areas designated as evacuation zones for storm surge
- d. Other areas impacted by stormwater/flood control issues

**Policy 3.1.6:**

As a basis for the designation of AAAs, the City will utilize the best available data and resources, such as the Unified Sea Level Rise Projection for Southeast Florida and Broward County's Priority Planning Areas for Sea Level Rise Map, in order to identify and understand the risks, vulnerabilities and opportunities to formulate timely and effective adaptation strategies.

**Policy 3.1.7.:**

As deemed to be in the best interest of the City, the City Commission may designate or remove designation by means of, but not limited to, the following mechanisms:

- a. Community Investment Program (Capital Improvement Plan)
- b. City Commission Resolution or Ordinance
- c. Comprehensive Plan via location description or map
- d. Other mechanisms as appropriate

**Policy 3.1.8.:**

Potential funding sources for the implementation of AAA's associated adaptation strategies include, but are not limited to:

- a. Federal and State grants and technical expertise assistance (in-kind)
- b. Local Stormwater Utility Fees and Community Investment Program (Capital Improvement Plan) prioritization
- c. Public/Private Partnerships
- d. Other sources

**Policy 3.1.9:**

Integrate AAAs into existing and future City processes and city-wide plans and documents which may include, but not be limited to:

- a. Community Investment Program
- b. Local Mitigation Strategy
- c. Strategic Plan
- d. Sustainability Action Plan
- e. Stormwater Master Plan
- f. Comprehensive Emergency Management Plan
- g. Unified Land Development Regulations
- h. Other related processes, plans and documents.

**Policy 3.1.10:**

Align and be consistent with, to the extent possible, relevant and current national, state, and regional adaptation strategy documents such as the Broward County Climate Action Plan, Southeast Florida Regional Climate Action Plan and The President's Climate Action Plan as well as other regional strategic plans, disaster mitigation plans, water management plans, transportation/transit plans, and climate change plans.

**Policy 3.1.11:**

Participate in, when appropriate, coordinated governmental, non-governmental and other appropriate agencies' proposed application requests for funding adaptation implementation projects.

**Policy 3.1.12:**

Collaborate and coordinate with appropriate local, regional and state governmental agencies, to the extent possible, toward the implementation of AAA adaptation strategies.

**Policy 3.1.13:**

Based on evolving rising seas data and associated vulnerabilities, to allow for flexible adjustments, preserve future strategic adaptation implementation options to maintain maximum resiliency in response to new risks and vulnerabilities. The City will take advantage of new emerging data and technological opportunities.

**Policy 3.1.14:**

Continue to foster effective collaborations, partnerships and coordination with national, state, regional and local partners to identify risks, vulnerabilities and opportunities associated with coastal hazards and the impacts from sea level rise.

## **ADMINISTRATION AND IMPLEMENTATION ELEMENT**

**Add/Amend Comp Plan Administration and Implementation Element (VII. Definitions):**

**Priority Planning Areas for Sea Level Rise Map, Broward County:** Map which identifies and illustrates vulnerable areas within Broward County that are at increased risk of flooding due to, or exacerbated by, seal level rise over the next fifty (50) years. Broward County generated this map in partnership with the South Florida Water Management District and the National Oceanographic and Atmospheric Administration.

**Protection:** Strategies that involve "hard" and "soft" structurally defensive measures to mitigate impacts of rising seas in order to decrease vulnerability while allowing structures and infrastructure to remain unaltered. Two examples are shoreline armoring and beach renourishment. Protection strategies may be targeted for areas of a community that are location-dependent and cannot be significantly altered or relocated, such as downtown centers, areas of historical significance, or water-dependent uses. (Adaptation Action Areas: Policy Options for Adaptive Planning For Rising Sea Levels, South Florida Regional Planning Council, 2013)

**Accommodation:** Strategies that do not act as a barrier, but rather alter the design through measures such as elevation or stormwater improvements, to allow the structure of infrastructure system to stay intact. Rather than preventing flooding or inundation, these strategies aim to reduce potential risks. (Adaptation Action Areas: Policy Options for Adaptive Planning For Rising Sea Levels, South Florida Regional Planning Council, 2013)

**Managed Retreat:** Strategies that involve the actual removal of existing development, their possible relocation to other areas, and/or prevention of further development in high-risk areas. (Adaptation Action Areas: Policy Options for Adaptive Planning For Rising Sea Levels, South Florida Regional Planning Council, 2013)

**Avoidance:** Strategies that involve ensuring development does not take place in areas subject to coastal hazards associated with sea level rise or where the risk is low at present but will increase over time. (Adaptation Action Areas: Policy Options for Adaptive Planning For Rising Sea Levels, South Florida Regional Planning Council, 2013)

Title: VICKIE MACHADO - Labeling of Genetically Engineered Food - House Bill 1

Minutes note: Vickie Machado introduced Maura Schlackman and Adrienne Bolton, who represent Food and Water Watch, a national consumer advocacy organization working locally to ensure that food and water is safe, accessible and sustainable. They have 30,000 supporters in the state and roughly 1,000 in Fort Lauderdale, more than 600 of which have signed a petition in support of labeling genetically-engineered (GE) food. She presented a fact sheet titled "The Case for GE Labeling," a sample resolution and the referenced petition for the record. Everyone should have the right to decide what to feed their families. There are GE food labeling bills in both the Florida House of Representatives and Senate. She requested that the Commission adopt a resolution supporting House Bill 1 and Senate Bill 558. Schlackman said she took an interest in this matter because she grew up on an avocado farm. Genetically modified organisms (GMOs) encourage greater pesticide use and monocultures, harming the environment and endangering the food supply by making people dependent on a small-number of crops. GMO labeling laws are a step toward a more sustainable, transparent and accountable food system. She noted the countries and states that support GMO labeling laws. Florida is a major agricultural state and has a chance to be a leader by adopting this resolution. Bolton, local coordinator for Food and Water Watch and a registered dietitian, said people have a right to know what is in their food. A labeling law helps establish that right to know. She believes that is what Fort Lauderdale residents want. She urged the Commission to support this matter. In response to Commissioner Rogers, Bolton said this is a national, state and local issue. In response to Mayor Seiler, Machado said Connecticut, Maine and Hawaii have passed labeling laws. GE foods would not be prohibited; they just have to be labeled. Vice-Mayor Roberts said he believes this is a matter of transparency. Many European countries have been doing this for a long time. It is about truth in labeling. Commissioner DuBose noted that generally when resolutions are presented, the City Attorney's Office is allowed to first review them. He recommended that they reach out to the Broward League of Cities, which serves as an umbrella agency for all the cities in Broward County. Mayor Seiler said he does not oppose the transparency but was unsure whether this is a city issue or something that would be better handled with individual letters of support from the Commission. He suggested the City Attorney's Office review the proposal and asked Machado to follow up with the City in about 30 days.

# The Case for GE Labeling

FACT SHEET • AUGUST 2012

**G**enetically engineered (GE) crops are created by transferring genetic material from one organism into another to create specific traits, such as resistance to treatment with herbicides or to make a plant produce its own pesticide to repel insects.<sup>1</sup> Unlike traditional plant and animal breeding, which tries to develop better varieties by selecting traits from the same species, genetic engineering techniques can insert specific genes from any plant, animal or microorganism into the DNA of a different species.

The first GE crops became commercially available in the United States in 1996, and now GE varieties constitute the vast majority of corn, cotton and soybean crops grown in the country.<sup>2</sup> At this point, most GE food crops are genetically engineered to produce a soil bacterium called *Bacillus thuringiensis* (Bt) that repels insects, or to allow the crop to withstand treatment with an herbicide, like glyphosate (often sold as Roundup).<sup>3</sup> More recently, biotechnology firms have developed genetically engineered animals, including food animals such as hogs and salmon.<sup>4</sup>

Proponents of the technology contend that these alterations are improvements because they add desirable traits. Yet companies submit their own safety-testing data, and independent research on GE foods is limited because biotechnology companies prohibit cultivation for research purposes in the restrictive licensing agreements that control the use of these patented seeds.<sup>5</sup>

Some of the independent, peer-reviewed research that has been done on biotech crops has revealed troubling health implications including deterioration of liver and kidney function and impaired embryonic development.<sup>6</sup> However, the Food and Drug Administration (FDA) has no way to track adverse health effects in people consuming GE foods, and because there is no requirement that foods containing GE ingredients be labeled,<sup>7</sup> consumers do not know when they are eating them.

## Major Commercially Available GE Crops<sup>8</sup>:

- alfalfa
- cotton
- canola
- papaya
- corn
- soy
- squash
- sugar beet
- sweet corn

The FDA does not require the labeling of GE food products as such because the agency views GE foods as no different from conventional foods. The FDA does permit voluntary GE labeling as long as the information is not false or misleading.<sup>9</sup> Food manufacturers are allowed to affirmatively label GE food or indicate that the food item does not contain GE ingredients (known as "absence labeling"). But virtually no companies disclose that they are using GE ingredients under this voluntary scheme. This means that consumers in the United States regularly consume foods that contain GE ingredients without knowing it.<sup>10</sup>

For consumers to have the opportunity to make informed choices about their food, all GE foods should be labeled. A 2008 CBS/New York Times poll found that more than half of American consumers would choose not to buy GE foods, and 87 percent wanted all GE ingredients to be labeled.<sup>11</sup> A 2010 Consumers Union poll found that 95 percent of U.S. consumers favor mandatory labeling of meat and milk from GE animals.<sup>12</sup>

Labeling GE foods is not a novel idea. The European Union specifically addresses the new properties and risks of biotech crops and evaluates the safety of every GE crop.<sup>13</sup> Additionally, the EU requires all foods, animal feeds and processed products with biotech content to bear GE labels.<sup>14</sup> Australia, Brazil, China, Japan, New Zealand, Russia, Saudi Arabia, and South Korea all require labels on GE foods, although their labeling thresholds vary from zero tolerance to 5 percent GE content.<sup>15</sup> Without an affirmative label on foods containing GE ingredients, the only way for consumers to avoid GE foods is to buy organic. The USDA National Organic Program prohibits the use of GE material in any product that carries the "certified organic" label.<sup>16</sup>

## Hidden GE Foods In Our Food Supply

Perhaps one of the reasons there is no requirement that GE food be labeled is that food companies do not want consumers to know exactly how much GE content there already is on supermarket shelves. Since most corn, cotton and soybeans are now genetically engineered, it can be assumed that ingredients made from these crops contain GE content. For example, corn starch, corn meal, corn syrup, glucose, dextrose, canola oil, cottonseed oil, soy oil, soy flour, soy lecithin and "protein extracts" — present in many processed foods — are all likely derived from GE crops.<sup>11</sup> Since the partial approval of Roundup Ready sugar beets, 95 percent of sugar beets grown in the United States are genetically engineered, so products containing sugar made from beets are most likely GE foods.<sup>12</sup>

Other foods with "hidden" GE content are dairy products like milk and cheese, that came from cows treated with rBGH, a GE growth hormone.<sup>13</sup> Most feed consumed by livestock consists of GE grains and grasses<sup>14</sup> — like Roundup Ready soybeans, corn and alfalfa — so dairy products and meat from these animals are considered GE foods as well.

Also, GE sweet corn, papayas and virus-resistant squash have been commercialized<sup>15</sup> and may be sold in supermarkets without a label.

Certified organic foods cannot be genetically engineered or contain GE ingredients.

It took government regulation to make food processors put ingredient lists and nutrition facts on food packaging — labels that consumers are now accustomed to seeing and are using to make food choices. But the government has failed to require that consumers get to know other basic information about our food, like that it is genetically engineered.

Tell your state and federal lawmakers you want mandatory labeling of genetically engineered foods.

**RESOLUTION**

WHEREAS, the City of \_\_\_\_\_ recognizes that consumers want accurate and thorough information about the food they feed their families; and

WHEREAS, the potential long-terms risks to public health and the environment from genetically engineered foods are unknown; and

WHEREAS, safety studies on genetically engineered foods are limited because biotechnology companies prohibit cultivation for research purposes in their seed licensing agreements; and

WHEREAS, some independent, peer-reviewed research that has been done on genetically engineered crops has revealed problems with liver and kidney functions in rats, deformities and neurological problems in vertebrates and lower nutrition content in Roundup Ready crops; and

WHEREAS, it is the responsibility of the United States Department of Agriculture to ensure that genetically engineered crops are safe to grow, the Environmental Protection Agency to ensure that genetically engineered products will not harm the environment and the Food and Drug Administration to ensure that genetically engineered food is safe to eat; and

WHEREAS, the patchwork of federal agencies that regulates genetically engineered crops and animals in the United States has failed to adequately oversee and monitor genetically engineered products; and

WHEREAS, farmers who produce organic or non-genetically engineered crops run the risk of crop contamination from nearby genetically engineered crops; and

WHEREAS, farmers who unintentionally grow genetically engineered-patented seeds or who harvest crops that are contaminated with genetically engineered traits could lose marketing options and face costly lawsuits; and

WHEREAS, a 2008 CBS/*New York Times* poll found that 87 percent of U.S. consumers wanted all genetically engineered ingredients to be labeled;
